# ABOUT CHAZ



Chaz Stevens, originally Timothy Richard Stevens (b. 1964), is a multifaceted figure in Florida. His repertoire includes roles as a political activist, former Housing Commissioner, artist, software developer, and ESADoggy co-founder, a for-profit entity offering remote animal-assisted therapy, all while championing various secular values.

At his core, Stevens is a fervent promoter of secularism and a staunch defender of First Amendment rights, focusing on the separation of church and state. His distinctive methodology fuses art with activism, leveraging creativity and satire to provoke discussion, challenge societal norms, and catalyze transformation.

Stevens' unapologetic and controversial approach has earned both acclaim and critique. He's viewed as a bold defender of free expression and secularism by some, but others criticize his confrontational style.

His influence is evident in sparking vital dialogues on religion, governance, and personal liberties, challenging the conventional on matters like school prayer and religious symbols in public venues.
